1. The present regular bail application has been filed on behalf of the accused petitioner namely **Mukul Kumar @ Mukul Kumar Raut, S/o Kallu Raut, aged about 26 years**, R/o Vill- Batraha Near Aanpurna Mandir, Sardar Nagar, Ward No. 27, P.S.- Sadar Saharsa & District- Saharsa, who is languishing in jail custody since 26.12.2025 in connection with RPF Saharsa P.S. Case No.-15/2025 registered under section 03 RP(UP) Act.
2. As per FIR, informant S.I. Sujit Kumar alleged that on 25.12.2025, he received secret information and informant and police team departed from Saharsa Post and reached the yard. They met constable Ranvir Kumar on duty and while monitoring for criminal activity then he observed that a person carrying a heavy sack on his shoulder going towards the south near the MG Loco Shed. On suspecting this, they all moved towards him. Upon seeing them, the person threw the sack and began to run. He was surrounded and caught on the spot. Upon interrogation the person disclosed his name as Mukul Kumar and also disclosed that he stolen Pandrol clip (jilebi) used in the railway line and a piece of railway track from the railway store. During the search of his sack, 10 pieces of Pandrol clip (jilebi) and 1 pieces of a four-hole fish plate were recovered. On the basis of above allegation the F.I.R. was registered.
3. Learned counsel for the petitioner submits that petitioner is quite innocent and has committed no offence and falsely been implicated in this case. No other bail application against this petitioner is pending either before this court or Hon'ble High Court Patna. That, from perusal of the F.I.R. u/s- 03 RP (UP) Act is not applicable against petitioner. Petitioner has two criminal antecedent vide RPF Post (SHC) Case No.- 13/2024 and 14/2024 in which he is on bail. He is languishing in jail custody since 26.12.2025.
4. On the other hand, Ld. Addl. P.P. opposed the prayer for bail.
5. Heard both the parties in detail and perused the case diary.
6. The FIR has been registered for the offence punishable under sections 03 RP(UP) Act. On perusal of the record, it transpires that it is alleged that the petitioner

was found in possession of 10 pieces of Pandrol clip (jilebi) and 1 pieces of a four-hole fish plate belonging to railway and amounting to rupees 3500/-. Prosecution report has been filed against the petitioner and he is languishing in jail since 26.12.2025. It would take time conclusion of trial.

7. Considering aforesaid facts and circumstances of the case coupled with period of custody of petitioner, the regular bail of petitioner namely **Mukul Kumar @ Mukul Kumar Raut, is hereby allowed.** He is directed to be released on bail on furnishing bail bond of Rs. 10,000/- with two sureties of like amount each to the satisfaction of Ld. Court below subject to the condition that one of the bailors of the petitioner must be his family member/ co-villager and further with the conditions, as laid down in Section 480(3) BNSS. Further, the accused shall file an undertaking to appear before court physically on each and every date till framing of charge and shall not indulge in similar offence, failing which it shall entail cancellation of bail. Accordingly, this bail application is disposed of.
8. The observation made in the present bail petition order are for purpose of deciding the present petition and do not affect the factual matrix of investigation / trial, which is separate issue as per law.
9. Office is directed to send the trial court record, if any, to the court concerned along with the copy of this order. Office is also directed to send the soft copy of this order to Jail Superintendent, Khagaria.
