The record is put up by petition.

Accused Majammel Haque @ Mojammel Haque on court bail is present by filing a verified petition praying for pleading his guilt.

Ld. P.P in-charge is present.

Ld. Advocate for the accused is also present.

Now, the petition for pleading guilty is taken up for hearing.

Heard both sides.

Ld. Lawyer for the accused submits that at this stage the accused person does not want to contest with the case as he has been suffering much about this case due to his economic condition. Now, he wants to dispose of the matter by way of pleading his guilt.

Ld. P.P in-charge and Ld. Lawyer for the WBSEDCL do not oppose the prayer of the guilt of the accused.

In course of hearing, the accused is orally examined by the court who has stated that he was fully aware about the charge brought against him and pleads guilty by saying that "Ami Dosh Korechhe."

After hearing it appears to me that his plea of guilt is clear and unambiguous and the same is free from any undue influence and coercion. Accordingly, the plea of guilt made by accused is accepted and he is convicted for the offence punishable under Section 135(1)(a) of the Electricity Act, 2003.

Hence it is,

ORDERED

that the accused namely Majammel Haque @ Mojammel Haque is found guilty for the offence under Section 135(1)(a) of the Electricity Act and convicted.

On being asked convict, Majammel Haque @ Mojammel Haque states that he is unemployed. He prays for mercy and lessor punishment due to his poor economic condition.

Considering the facts and circumstances of the case as well as his poor economic condition, I am of the view that the fine of Rs.250/- would be appropriate and justified for the convict Majammel Haque @ Mojammel Haque.

Accordingly the convict Majammel Haque @ Mojammel Haque is sentenced to pay fine of Rs.250/- i.d, simple imprisonment for one day.

The above accused Majammel Haque @ Mojammel Haque is released from his bail bond.

The surety of the above accused Majammel Haque @ Mojammel Haque also be discharged from the liability of the bail bond.
