This miscellaneous application is preferred at the instance of the State of West Bengal represented through the Principal Secretary, Department of Land & land Reforms and Refugee Relief and Rehabilitation, Nabanna, Howrah and others against Sri Narendra Kumar Anchalia and others against arbitral award dt. 31.08.2024 passed by Ld. Sole Arbitrator appointed by Hon'ble Apex Court, India in Civil Appeal no. 2672/2024 arising out of SLP (C) 2698/2024. Order sheet of the instant file further reveals that the Miscellaneous Application no. 97/2024 is yet to be admitted. Instant prayer dt. 22.05.2025 preferred by Ld.
