This case having been finally heard on 09/05/2025 and the court on the same day delivered the following:-

ORDER

1. The final report in this case is filed by the Inspector of Police, Elavumthitta Police Station in Crime No.524/22 against the accused alleging offences punishable U/Ss.143,147,148,341,323,324,307 r/w 149 of IPC.
2. The prosecution case, in short, is as follows:- The defacto complainant and others were the volunteers of Dream and sports club, Nallanikunnu and Onam celebrations were in progress under the leadership of that club on 9/9/22. As the functions were in progress, at about 2.00 am the accused persons formed themselves into an unlawful assembly, created disturbances and when the defacto complainant and others as volunteers of the club intervened to settle the commotions, they were stabbed and beaten up by the members of the unlawful assembly. Thereby the accused are alleged to have committed the offences punishable u/Ss 143, 147, 148, 341, 323, 324,307 r/w 149 of IPC.
3. On filing of the final report, this court took cognizance of the offences punishable u/Ss.143,147,148,341,323,324,307 r/w 149 of IPC. On appearance of the accused, copies of relevant prosecution records were furnished and thereby complied with Section 207 of Cr. P.C.
4. On perusal of the case records, it appears that the offences alleged against them are exclusively triable by the Hon'ble Court of Sessions, and therefore the case is to be committed to the Hon'ble Sessions Court for trial. In these circumstances, the case of the accused is committed to the Hon'ble Court of Sessions, Pathanamthitta under Section 209 Cr.P.C.
5. In the result,
 1. This case is committed to the Hon'ble Court of Sessions, Pathanamthitta under Sec. 209(a) of Cr.P.C.

2. The accused are on bail, and they are directed to appear before the Hon'ble Sessions Court as and when directed to do so.
3. Forward the entire records to the Hon'ble Court of Sessions forthwith.
4. Forward the properties, if any, to the Hon'ble Court of Sessions, Pathanamthitta when it is so directed by the Hon'ble Court.
5. Notify the learned Public Prosecutor, Pathanamthitta as to the committal of case to the Hon'ble Court of Sessions, in compliance with Section 209(d) of CrPC.
