15.09.2018 The record is put up on the basis of a put up petition filed on behalf of the accused/petitioner Sahaban Mondal.

Ld.Advocate filed the certified copy of the order passed by the Hon'ble Court on an application u/s 439 Cr.P.C. filed by the present accused along with a letter of Ld.Advocate in his letter head.

It appears from the certified copy of the order of the Hon'ble Court that Hon'ble Court vide CRM no.7504 of 2018 in connection with Murarai P.S. case no.239/2018 dt.18.06.2018 corresponding to special case no.22/2018 u/s 4 of POCSO Act pending before this court was pleased to enlarge the accused on bail and directed, *"Accordingly, the petitioner is directed to be released on bail upon furnishing a bond of Rs.10000/- with two sureties of like amount, one of whom must be local, to the satisfaction of Ld.Judge, Special Court (POCSO), Rampurhat, Birbhum on condition that he shall not intimidate the witness or tamper with the evidence in any manner whatsoever and shall appear before trial court on every date of hearing and in the even he failed to do so the trial court shall be at liberty to cancel his bail with further reference to this court.*

*This order is subject to further condition that the petitioner will remain restrain from entering any place within the jurisdiction of Murarai P.S. except for the purpose of calling on the investigating officer with prior appointment once a week and if there is any such default in such regard the State will will be entitled to seek cancellation of bail....."*

Accordingly one petition on behalf of the accused is filed with a prayer to submit the bail bond.

The Register of surety is lying with the Ld.A.C.J.M. Rampurhat.
