Upon perusal of this petition as well as going through the Charge Sheet, I do find that the petition contents some merit and without examine this persons no logical conclusal of this case can be achieved. As such the petition u/s-311 Cr.P.C is considered and allowed.

Issue summons upon the witnesses Subrata Roy to held magisterial inquest of dead body, Abdul Kuddus the scribed, C/188 Suprobbat Ganguly and Dr. Goutam Ghosh(Jr.).

13. After recording this evidence Ld. Special PP filed P.R bond of Rs. 500/- for accused Bulu Sk and Sariful Sk. Record shows on 30-09-2025 non bailable warrant were issued against these witnesses. Both these witnesses is produced today by O/C Margram P.S and they are examined, cross-examined in full and discharged. It appears to this Court that purpose of issuing non bailable warrant has already been served and that being so this court find no reason for their further detention. Accordingly both witnesses Bulu Sk and Sariful Sk are allowed bail and both of them are permitted to file P.R bond of Rs. 500/- each. If prayer for bond filed they be released and discharged.
