Today is fixed for production of the aced and the evidence of the victim .

The aced Sk Ali Md is produced before this court and taken into custody and remanded to the J/C till 07.05.25.

The victim is present. Ld . P.P.In-Charge files a hazira of interpreter namely Shibnath Chakraborty O/C Khayrasole has sent the camera man for Audio video recording of the deposition of the victim who is a deaf and dumb girl.

The witness Swati Dalui is not present . Accordingly the case is adjourned.

Ld P.P.is take necessary steps upon the witness Swati Dalui. to remain present on the next date for assistance in the recording of the deposition of the victim.

The victim is handed over to the constable for safe return to her house. Th bail ptn is taken up for hearing . Heard both sides at length.

ON perusal of the materials of the case record it appears that the victim is a deaf and dumb girl. The examination of the victim is still not complete. It is a case of rape of a deaf and dumb girl. The trial of this case is on full swing. At the stage the release of the aced will have adverse affect on the trial of the case . Accordingly the bail ptn is stands rejected and remanded to J/C.

The O/C Khayrasole P.S is further directed to make necessary arrangement for audio video recording of the deposition of the V.G.

The Principal/ headmaster of the recognized deaf and dumb school of Suri District Birbhum is hereby requested to appoint himself / herself or depute one of the teacher of the school for recording of deposition of the victim of this case.

Let a copy of this order be sent to the legal cell of the D.M Suri , Birbhum .

The O/C Khayrasole P.S is further directed to make necessary arrangement for presence of the victim on the next date -with necessary force

The superintendent of the District Correctional Home ,Suri is directed to produce the aced on the next date i.e 04.06.2025 positively.

The Superintendent of Suri Sadar Hospital is requested to provide interpreter namely Shibnath Chakraborty with the necessary instrument for assistance in the recording of deposition of the victim on the next date i.e. 07.05.2025.

Fix 04.06.25 for Production and the evidence .

Prosecution is to issue summons.

The aced remains in J/C .
