assisted by Ld. Counsel for complainant that prosecution has already  
examined PW-14 Gauri and PW-16 Sanjana on the similar facts which  
are to be deposed by PW Sheikh Jamila. It is stated by Ld. Addl. PP for  
the State that the said prosecution witness may be dropped/deleted from  
the list of witnesses as he does not intend to examine the witness who has  
to depose similar facts which already stand deposed before the Court by

the other prosecution witnesses. Submission of Ld. Addl. PP for the State not objected to by Ld. Counsel for complainant/witness.

Submissions heard. Record and previous examination of prosecution witnesses perused.

Submissions of Ld. Addl. PP for the State and Ld. Counsel for complainant appear justified in the facts and circumstances of the present case. Accordingly, request is accepted. Name of PW Sheikh Jamila stands **dropped/deleted** from the list of prosecution witnesses.

Summons to PW Shabir Ahmed received back unexecuted from his given address with remarks 'no such person resides at the given address'. One last opportunity is granted to prosecution to produce the witness. Fresh summons be issued to PW Shabir Ahmed to be executed through concerned DCP Shahdara returnable on date already fixed.
