A petition for putting up the record with surrender petition and with a bail petition along with a fresh Vakalatnama filed on behalf of the accused person namely, Lob Sarkar by his Ld. Advocate wherein the Ld. Advocate prayed for enlarging the accused person on bail on the ground stated therein. Copy served. Let the Vakalatnama be kept with the record.

The put up petition is considered and allowed.

The accused person above-named voluntarily surrendered before this court.

The surrender of the accused person is hereby accepted. He is taken into custody and remanded to J.C. Recall W/A at once.

The bail petition is taken up for hearing.

Perused the bail petition along with the record. Heard Ld. Advocate for the accused person and Ld. Special P.P.-in-charge.

Ld. Advocate for the accused person submitted that the accused person voluntarily surrendered before this court and further submitted that this court was pleased to issue W/A against the accused person above named on 02/04/2026 for his non-appearance before this court. Ld. Advocate again submitted that due to the miscommunication, he could not appear before this court on the scheduled date and accordingly, prayed for releasing him on bail by imposing any condition.

Ld. Special P.P.-in-charge raised formal objection and submitted in the open Court that W/A was issued against the above named accused person as he did not appear before this court on previous date and as such, the charge has not been framed against him along with 04 accused persons of this case. He further submitted that if the accused person will be released on bail, he must appear on all the dates of further proceedings.

Considering the rival submissions of both sides and on perusal of the record, it reveals that the above-named accused person did not turn up before this Court as such, W/A was issued against him on 02/04/2026, as on that date the accused person was absent without any justifiable ground.

When the accused person voluntarily surrendered before this court, I find no justifiable ground to detain him behind the bar. Hence, the bail petition is hereby allowed with a condition that he will remain present positively on each and every date on all further proceedings of this case.

Accused person, namely, Lob Sarkar may find bail of Rs. 3000/- with two sureties of Rs. 1500/- each other than previous one, to the satisfaction of Ld. C.J.M., Purba Bardhaman i.d. to J.C.

If on bail to date i.e. 08.09.2026 for appearance and for passing further order.

Let a copy of this order be sent to the Ld. C.J.M., Purba Bardhaman with a request to accept the bail bond and after accepting bail bond, return the bail bond to this Court for keeping the same for future reference.
