Order no. 03 dated 10.07.2026:

The application for anticipatory bail under Section 482 B.N.S.S. filed on behalf of the accused petitioners namely (1) Amit Kesh @ Amit Kes, (2) Dipa Bagdi, (3) Totan Kharat @ Taton Khanrat, (4) Nayan Bagdi, (5) Saheb Ghosh, and (6) Totan Mondal @ Toton Mondal who apprehend arrest in connection with Galsi P.S. Case No. 442 of 2026 dated 07.06.2026 U/Ss 331(6)/118(2)/109(1)/308(5)/303(2)/324(4)/351(2)/3(5) of B.N.S. is taken up for hearing.

L.C.R. received. C.D. is also produced.

Heard the Ld. Advocate for the petitioners and Ld. P.P. In-charge.

It is submitted by the Ld. Advocate for the petitioners that these accused persons did not commit any serious offence and they have been falsely implicated in this case out of political grudge, and nature of allegation is as such, custodial interrogation of the petitioners is not required. It is the further submission of the Ld. Advocate that no such application of these petitioners has either been moved before or rejected by the Hon'ble Court or by this Court on any earlier occasion. Hence, Ld. Advocate prays for grant of anticipatory bail to the petitioners on any condition as this Court deems fit.

Mild objection raised by the Ld. P.P. in-charge.

Considered the submissions placed. Perused the materials available on record and in the C.D. including the injury report.

Considering the materials available in the C.D., nature of allegation and injury, and facts and circumstances, I am of the view that custodial interrogation of the present petitioners is not needed in this case. Accordingly, their prayer u/s 482 B.N.S.S. is allowed.

In the event of arrest of the above named petitioners in connection with the above noted case, they shall be released on bail on furnishing bonds of Rs. 3,000/- each with two sureties of Rs. 1,500/- each, subject to the satisfaction of the arresting officer, on the conditions stipulated in section 482(2) B.N.S.S.

Let a copy of this order along with the L.C.R. be transmitted to the concerned Court for information and necessary action.

C.D. be returned.
