Order no. 02 dated 09.07.2026:

The application for anticipatory bail under Section 482 BNSS filed on behalf of the accused petitioners namely, (1) Subrata Mukherjee and (2) Susanta Kumar Bhattacharya who apprehend arrest in connection with Bhatar P.S. Case No. 313 of 2026 dated 06.06.2026 U/Ss 323/354/386/506/34 of IPC is taken up for hearing.

Record of G.R. Case received. C.D. is also produced.

Heard the Ld. Advocate for the petitioner, and Ld. P.P. In-charge.

It is submitted by the Ld. Advocate for the petitioners that the petitioners have been falsely implicated out of political rivalry. No such incident as alleged in the FIR took place. The complainant is present in court with her Ld. Advocate. It is further submission of the Ld. Advocate that no such application of this petitioner has either been moved before or rejected by the Hon'ble Court or by this Court on any earlier occasion. Hence, Ld. Advocate prays for grant of anticipatory bail to the petitioners on any condition as this Court deems fit.

Ld. P.P. In-charge raises mild objection.

Ld. Advocate for the complainant entered appearance by filing Vokatnama. The Ld. Advocate submits that the complainant has shown affidavit declaring her no objection.

It is alleged that in the year, 2023 the petitioner with their associates collected a total sum of Rs. 20,00,000/- (Rupees twenty lakhs) from the villagers for extending the benefit of Social Welfare Scheme namely, Awas Yojana. However, considering the subsequent development, the prayer for anticipatory bail is allowed.

In the event of arrest of the above named accused petitioners in connection with the above noted case, he shall be released on bail on furnishing bonds of Rs. 10,000/- with two sureties of Rs. 5,000/- each, subject to the satisfaction of the arresting officer, on the conditions stipulated in section 482(2) of BNSS with further direction that the petitioner shall meet with the I.O. of the case once in a week till completion of investigation.

Let a copy of this order along with the record of G.R. Case be transmitted to the concerned Court for information and necessary action.

C.D. be returned.
