

Special Case No . 02 of 2025

Order No. 11 dt. 30.06.2026

The record is put up before me on the basis of a put up petition dated 30/06/2026 filed by the Ld. Advocate on behalf of the accused namely **Md. Mumtazul Islam @ Juel** in connection with the instant case along with a photocopy of the order downloaded from the official site of Hon'ble High Court Calcutta, passed by the Hon'ble High Court dated 23.06.2026 in **CRM (M) 325 of 2026** in respect of the above named accused. The order of the Hon'ble Court is as follows :-

Having considered the period of detention of the present petitioner and the factum that the present case is solely based on documents, at this stage, I am of the opinion that further detention of the present petitioner is uncalled for.

Hence, the prayer for bail of the petitioner is Allowed.

Accordingly, the petitioner viz, Md. Mumtazul Islam @ Juel shall be released on bail upon furnishing bond of Rs. 20,000/- (Rupees Twenty Thousand only) with two sureties of Rs. 10,000/- (Rupees Ten Thousand only) each, one of whom must be local, to the satisfaction of the Learned CJM, Purba Bardhaman/ Burdwan.

If on bail, the petitioner shall also make himself physically available on each and every date so fixed by the learned trial court and shall not leave the district of Purba Bardhaman / Burdwan without prior permission of the learned trial court.

Further, the petitioner after his release for the next six months meet with the Investigation Officer of the case once in a fortnight. It would be the learned trial court to decide whether such condition should be extended or waived.

Accordingly, CRM (M) 325 of 2026 is allowed.

After perusal of the order of Hon'ble High Court and perusal of the above petition, it reveals that the Hon'ble High Court was pleased to direct that the accused/petitioner shall be released on bail on furnishing bond of Rs.20,000/- with two registered sureties of **Rs. 10,000/- (Rupees Ten Thousand only) each one of whom must be local , to the satisfaction of the Learned CJM, Purba Bardhaman/Burdwan.**

In view of the above order passed by the Hon'ble Court as mentioned above, the accused namely **Md. Mumtazul Islam @ Juel** is directed to furnish bond of Rs.20,000/- with two registered sureties of **Rs. 10,000/- (Rupees Ten Thousand only) each one of whom must be local , to the satisfaction of the Learned CJM, Purba Bardhaman/Burdwan.**

Since this Court and Office is not maintaining any Bail Bond Register and the same is maintained by Ld. CJM, Purba Bardhaman so Ld. CJM, Purba Bardhaman is requested to check, verify/fitting of the bail bond so furnished by the accused above named for necessary compliance, pursuant to the order of Hon'ble High Court, Calcutta. After fitting of the bail bond, Ld. CJM, Purba Bardhaman is also requested to sent back the same to this Court for its acceptance.

Let a copy of this order be sent to Ld. CJM, Purba Bardhaman at once for his information and necessary action.
