**SUIT CLAIM:** This suit was filed on **05.01.2017** by the Plaintiff and prays to pass a Judgment and decree against the defendant:

- a) To grant a decree for a sum of Rs.10,88,261/- (Rupees Ten Lakhs Eighty Eight Thousand Two Hundred Sixty One only) along with 24% p.a. interest against the defendant;
- b) To grant such other relief or reliefs;
- c) To award cost of the suit.

This suit coming on this day for final disposal before **Sri. B.G.Pramoda, LII Additional City Civil and Sessions Judge, Bengaluru City**, in the presence of **Sri. B.R.Sridhara - Advocate for Plaintiff and Defendants** placed ex-parte.

**It is ordered and decreed that the suit filed by the plaintiff firm under Sec.26 read with Order VII Rule 1 of CPC, is hereby partly decreed with cost.**

It is further ordered and decreed that the defendants are held liable to pay sum of Rs.10,88,261/- (Rupees Ten Lakhs Eighty Eight Thousand Two Hundred Sixty One only) to the plaintiff firm.

It is further ordered and decreed that the defendants are also held liable to pay future interest at the rate of 6% p.a. on Rs. Rs.10,88,261/- from the date of institution of the suit till the date of realization of decretal amount.

And that a sum of Rs.66,666/ be paid by the defendants to the plaintiff on account of costs of the suit.
