In view of the order of the Hon'ble Circuit Bench of Hon'ble Calcutta High Court at Jalpaiguri dated 22.09.2023 in CRM (NDPS) 768 of 2023 the accused Jigme Wangchuk Bhutia @ Jigme may be released on bail on condition of furnishing a bail bond of Rs. 10,000/- with two sureties of like amount each, one of whom must be local, to the satisfaction of this court and on further condition that he shall not leave the territorial jurisdiction of the trial court during the entire period of trial and shall attend each and every date of trial and he shall not directly and indirectly make any inducement, threat promise to any person acquainted with the facts and circumstances of the case so as to dissuade such person from disclosing such facts to any police officer or the court and / or temper with the evidence in any manner whatsoever and he shall also meet with the officer in charge, Kalimpong P.S. once a week.

Let a copy of this order be sent to the Ld. C.J.M., Kalimpong for his information and taking necessary action.

If the accused furnishes the bail bonds before the Ld. C.J.M., the Ld. C.J.M., Kalimpong is directed to make the bail bonds furnished by the accused fit and to

transmit the same to this court for its acceptances as well as issuance of release order of the accused Jigme Wangchuk Bhutia @ Jigme.

Thus, this petition hereby stands disposed of.
