Order No.16, dated 07.01.2019

Out of (10) accused persons, since the case against the accused Sanjoy Gupta @ Felu has been filed for ever vide order no.12, dated 10.09.2018 owing to death of the said accused, there are (09) accused persons in this case at present, of whom the accused . Amar Singh @ Kalu, on Court bail, is present in Court and files hajira.

The accused, namely 1. Deba Pashi @ Gulgulia @ Bulia, and 2. Sagar Sk. @ Sagar Roy @ Nona on Court bail, are absent by separate petitions each with a prayer for fixing another date for appearance.

Accused Chandan Dom @ Bulet, is produced from Burdwan Central Correctional Home.

Another accused Bishu Kurmi, on Court bail, is found absent on call though hajira of a lawyer appointed through Legal Aid Services for the said accused and the accused Sagar Sk. @ Sagar Roy @ Nona, has been put in.

This date is fixed for appearance of the aforesaid accused persons on bail as well as for E.R. of W.A. in respect of other accused persons.

N.E.R. of W.A., in respect of other five accused namely, 1. Raju Rajbanshi, 2. Sk. Amir @ Bengal, 3. Manoj Shaw and 4. Ajoy Pandit, is received from Burdwan P.S. with a prayer for allowing further time for E.R.

Prayer is considered and allowed.

Fix 01.03.2019 for appearance of the accused persons on bail as also for E.R. of W/A in respect of the other accused persons.

The accused Chandan Dom @ Bulet is remanded in Burdwan Central Correctional Home till 01.03.2019 and he be produced before the transferee Court on the said date.

No appointment letter of any advocate from defence panel to defence accused Chandan Dom @ Bulet, is received from D.L.S.A., Burdwan.

Issue reminder to the Secretary, District Legal Services Authority, Burdwan, directing him to appoint a lawyer from the defence pannel of the Legal Aid Services, to defend the accused Chandan Dom @ Bulet, and also to submit a report to that effect, before this Court by 01.03.2019.

The sureties concerned of the absentee accused persons are directed to produce the said accused persons on the next date positively i/d W/A will be issued.

To date (01.03.2019) for appearance of the accused on bail.

A copy of this order be sent to the Inspector-in-Charge, Burdwan P.S. for information and strict compliance.

Another copy of this order be sent to the Secretary, District Legal Services Authority, Burdwan for information and taking necessary action.
