Out of rest 9 accused persons, two accused persons namely (1) Deba Pashi, and (2) Amar Singh @ Kalu on court are present by filing haziras and they are placed on the dock.

Another accused Chandan Dom @ Bulet is produced from J/C and he is also placed on the dock.

Two other accused persons namely Bishu Kurmi and Sagar Sk. @ Sagar Roy @ Nona on bail are absent without any step.

Original W/A along with a report is received from Burdwan P.S. stating that accused SK. Amir @ Bangal is in custody in connection with Burdwan P.S. Case No. 20/19 dated 12.01.2019 and prayer is made to take him in custody in connection with this case.

N.E.Rs. of W/As in respect of accused persons namely (1) Manoj Shaw (2) Ajay Pandit, and (3) Raju Rajbanshi, received from Burdwan P.S. with prayer for time for execution of the same on the grounds stated therein.

On perusal of the record it appears that W/A in respect of the above named accused persons were issued long back asking the I/C, Burdwan P.S. to execute the same and to submit execution report on the date fixed but even after lapse of several dates except N.E.Rs, no fruitful result yielded.

Under such circumstances, the Inspector In charge of Burdwan P.S. is again directed to look into the matter and to take necessary steps so that the W/A issued against accused (1) Manoj Shaw S/O- Lt. Ramsogath Shaw of Mehedi Bagan, P.S.- Burdwan, (2) Ajoy Pandit, S/O- Murari Pandit of Laxmipur Math, P.S.- Burdwan, and (3) Raju Rajbanshi, S/O- Lt. Prabhu Rajbanshi of Alamganj, FCI Godown, Dompura, P.S.- Burdwan be executed and positive execution report may be submitted before this court positively by the next date fixed.

As regards another accused person namely Sk. Amir @ Bangal, S/O- Sk. Sabir of Bara Bazar, B.C. Road, P.S.- Burdwan, Superintendent of Burdwan Central Correctional Home, Burdwan is asked to produce the said accused before this court on the next date fixed if said accused is in his custody in connection with the above noted case.

Now, the petition for bail filed on behalf of the accused Chandan Dom @ Bulet is taken up for hearing.

Heard the Ld. Advocate for the accused person and Ld. P.P. In-charge.

Considering the materials on record and situation depicted before me and also considering the period of detention undergone by this accused, I am inclined to allow his prayer for bail.

Accordingly, the accused person namely Chandan Dom @ Bulet may find bail on his furnishing bond of Rs. 3000/- with two sureties of Rs. 1500/- each, subject to satisfaction of Ld. C.J.M. Burdwan.

Inform Ld. C.J.M. Burdwan with a copy of this order, with direction to issue the release order directly to the Burdwan Central Correctional Home, Burdwan if bail bond furnished by him is found fit and accepted.

Sureties concerned of the accused persons namely Bishu Kurmi and Sagar Sk. @ Sagar Roy @ Nona are directed to produce the accused persons before this court on the next date fixed failing which W/A would be issued against them.

Inform all other concerned.
