Today is fixed for appearance of the accused persons on bail, production of accused (1) Chandan Dome and (2) Raju Rajbanshi, and E.R. of W/A against accused (1) Bishu Kurmi, (2) Manoj Shaw and (3) Sagar Sk. @ Sagar Roy @ Nona from Burdwan P.S. and against accused Amar Singh @ Kalu from Pandabeswar P.S.

Two accused persons namely (1) Sk. Amir and (2) Deba Pashi on bail are absent by petition and time is prayed for their appearance on the grounds stated therein.

N.E.R. in respect of accused (1) Manoj Shaw and (2) Sagar Sk. @ Sagar Roy @ Nona received from Burdwan P.S. seeking further time for execution of W/A against them.

Prayers are allowed.

As regards accused Bishu Kurmi a report is submitted by the I/C, Burdwan P.S. stating therein that said accused has died in the year 2021. Report submitted appears to be cloudy.

Record reveals that previously this accused was arrested and released on bail on 24.02.2021 and since then he is not appearing before this court.

Hence, I/C, Burdwan P.S. is directed to submit a definite report as regards the death of accused Bishu Kurmi by the next date fixed.

No E.R. of W/A in respect of accused Amar Singh @ Kalu received from Pandabeswar P.S.

It appears from the record that fresh W/A against this accused was issued by this court on 23.02.2021 but since then neither any E.R. or anything has been submitted by the O/C, Pandabeswar P.S. in spite of repeated reminders.

Under such circumstances, the Commissioner of Police, Asansol – Durgapur Police Commissionerate is requested to look into the matter and to take necessary step so that the W/A issued against accused Amar Singh @ Kalu, S/O- Bihari Singh of Pandabeswar, DVC Para, P.S.- Pandabeswar be executed and execution report be submitted before this court by the next date fixed. The accused persons namely (1)Chandan Dome, and (2) Raju Rajbanshi are produced from J/C. An application praying for their release on bail on the grounds stated therein has been filed. Copy served.

Ld. Advocate for the accused persons and Ld. P.P. are present.

The petition for bail is now taken up for hearing. Heard both sides.

It is submitted that earlier the accused persons were on bail but for their non appearance W/A was issued against them and on the strength of W/A they were arrested and are in custody for a considerable period of time.

Objection raised by the Ld. P.P.

Perused the materials on record. Considered the submissions placed.

Considering the fact that earlier the accused persons were on bail and they are in custody for a considerable period of time, their prayer for bail is allowed.

The accused persons namely (1)Chandan Dome, and (2) Raju Rajbanshi may find bail on furnishing bonds of Rs. 1000/- each with two sureties of Rs. 500/- each, subject to the satisfaction of Ld. C.J.M. Burdwan.
