

**Crim. Bail App. No.87/2026
Atharwa Vs. State**

**ORDER BELOW EXH.1 IN CRIM.BAIL APPL. NO.87/2026
CNR NO.MHOS160002892026**

01. The applicant/Accused 1) **Atharva @ Ganesh Nandkumar Khardekar, age 19 years**, 2) **Rana @ Arnav Ajay Sarwade, age 18 years**, in the event of their arrest, seeking anticipatory bail U/sec. 482 of B.N.S.S. in crime No.301/2026 registered with Kallam Police-station for the offences punishable u/sec. 3(5),351(3), 351(2), 352,115(2),118(1),118(2) of B.N.S. 2023.

02. Perused bail application, say of I.O./Ld.A.P.P. and investigation papers. Heard Ld. Adv. Shri.A.R.Shinde on behalf of the applicants and Ld.A.P.P. Shri.A.S.Kulkarni for State, at length.

03. On perusal of FIR, it appears that, the informant Abhijit Sanjay Ambirkar lodged complaint before Kallam police station on 16.07.2026 alleging therein on 16.07.2026 he alongwith his friend Yash Dilip Jadhav had came in Kallam city for purchasing mobile when they reached in front of Deshmukh Hospital, Anshu Kasbe called to him. Therefore they had been towards him. At that time Pratik Gaikwad, Ganesh Khardekar, Rana Sarwade also present. They abused him in filthy language and assaulted to him by stone on his head therefore he sustained injury on his surface. He also assaulted on his cheek. Then his friend Yash intervened the said quarrel, Pratik Gaikwad and Ganesh Khardekar assaulted to him by kick and hand blow. Rana also assaulted to his friend and they

threatened to kill him. Therefore, informant lodged the complaint.

04. It is the contention of applicants that they have not committed any offence, as alleged by the informant. They are falsely involved in this case. But on the basis of false offence, I.O. is trying to arrest them. Therefore they prayed, they be released on pre-arrest bail.

05. I.O./Ld. A.P.P filed their say, stating therein present accused committed serious offences against the informant and his friend. So, their custodial interrogation is essential one. Therefore, it is prayed for rejection of bail application.

06. However, on perusal of FIR, it appears that main allegation is against accused Anshu Kasbe. Allegations against present applicants is that they also assaulted to the friend of the informant by kick and hand blow. On perusal of police papers it appears that said stone is seized on spot by I.O. So nothing is to be recovered from the present applicants. Considering the role of present applicant in present crime they are entitled to be released on pre-arrest bail on certain conditions. Hence, I proceed to pass following order.

ORDER

1. The application is hereby allowed.
2. In the event of arrest of Applicants/Accused Nos.1) **Atharva @ Ganesh Nandkumar Khardekar, age 19 years**, 2) **Rana @ Arnav Ajay Sarwade, age 18 years**, involved in crime No.301/2026 registered with Kallam Police-station for the offences punishable u/sec.3(5),351(3),351(2),352,115(2),

118(1),118(2) of the BNS, 2023 be released on following terms and conditions :-

(A) They be released on P.B. of **Rs.50,000/- (Fifty thousand only) each** with surety of like amount.

(B) They shall produce his identity proof, address proof and mobile number with bail papers.

(C) They shall attend concern Police-station on each Monday and Friday in between 11:00 AM to 1:00 PM and co-operative to the Investigation Officer, till filing of charge-sheet.

(D) They shall not hamper and tamper prosecution witnesses.

(3) Breach of any of the above conditions will amount to cancellation of bail granted to the Applicant/Accused persons.

(4) Inform the concerned police-station, accordingly.
