Accused persons Sunil Tudu and Md. Ayaz Ali are produced from correctional home.

Received supplementary case record from Ld. ACJM, Durgapur along with executed W/A, arrest cum-inspection memos and medical examination reports and order sheet of the Ld. ACJM, Durgapur dated 13.09.2025 mentioning that the accused persons Sunil Tudu and Md. Ayaz Ali were brought under arrest before the court of Ld. ACJM, Durgapur on the basis of warrant of arrest issued by this court.

Let those be kept with the record.

At this stage, separate bail applications are filed on behalf of the accused persons.

A vokatatnama on behalf of the accused Md. Ayaz Ali has been filed.

Let the same be kept with the record.

Now the bail application of Md. Ayaz Ali is taken up for hearing and passing order.

The Learned Advocate for the accused submits that the accused could not appear before this court due to miscommunication and his non appearance was neither intentional nor deliberate and as such the Ld. Advocate for the accused prays for bail.

Ld. PP in Charge prayed for passing necessary order.

Perused the materials on record.

It is transpired from the record that the warrant of arrest was issued against the accused vide order dated 08.09.2025 due to his non appearance as he could not appear due to miscommunication.

Considering the facts and circumstances of this case, I am inclined to grant bail to the accused and it is,

ORDERED

That the accused **Md. Ayaz Ali** may find bail of **Rs.2,000/-** with one registered surety of like amount subject to the satisfaction of Ld. ACJM, Durgapur i.d to J.C.
