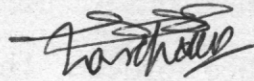


to the concerned Police station for its due execution, The Complainant is awaiting the report of the same.

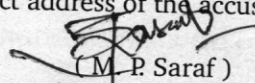
ORDER IN C.C.No.1074/SS/2018
