ORDER

**(Delivered on this 12th day of the month of May of the year
2026)**

1. By this Order, I shall dispose of the application filed by the
applicant under Article 248 of the Portuguese Civil Code, 1912.

2. **Case of the applicant:** in brief, this is an application filed
by the applicant Mr. Aldrich Ryan Fernandes order to obtain a
certificate/permission from the Court under Article 248 registration
Code 1912 of the Codigo de Registo Civil, for Registration of

Marriage in Goa, to the effect that the applicant being a Portuguese National, desires to register his marriage in Goa with Ms. Swezel Vandy Fernandes, daughter of Mr. Thomas Santana Piedade Fernandes and Mrs. Milagrina Fernandes.

3. The applicant was born on 02.03.1997 at Dr. Menezes Nursing Home, Margao Goa and he is holder of Portuguese Passport bearing No. CD173471, issued on 27.12.2022 and expiring on 27.12.2027 and also a holder of OCI card bearing No. A4981511, issued on 17.10.2023.

4. The applicant states that the previous marriage of the proposed bride of the Applicant Ms. Swezel Vandy Fernandes with Mr. Sanzil Dias under Marriage Registration No. MR-SAL-17-2022 has been annulled vide Judgment and Decree dated 11.04.2025 passed by the Court of the Civil Judge Senior Division at Margao, Goa bearing Case No. MP/12/2025/I and the said marriage has been cancelled on 23.06.2025 in the register of office of the Civil cum Sub Registrar at Salcete, Goa.

5. The applicant and Ms. Swezel Vandy Fernandes propose to register their marriage with the Civil Registrar of Salcete, Margao, Goa.

6. The applicant being Foreign National and Ms. Swezel Vandy Fernandes need permission of this Court which is necessary for the Civil Registrar of Salcete, Margao, Goa to register their marriage.

7. In support of his application the applicant has relied upon the following documents:

- Notarized copy of the Portuguese Passport of the applicant;
- Notarized copy of Birth Certificate of the applicant;
- Notarized copy of OCI Card of the applicant;
- Notarized copy of Birth Certificate of the proposed bride of the applicant Ms. Swezel Vandy Fernandes;
- Notarized copy of Residence Certificate of the proposed bride of the applicant Ms. Swezel Vandy Fernandes;
- Notarized copy of Aadhaar card of the proposed bride of the applicant Ms. Swezel Vandy Fernandes.

8. The applicant has also relied upon the Marriage Teor of his proposed bride Ms. Swezel Vandy Fernandes having endorsement of annulment of her previous marriage with Mr. Sanzil Dias issued by the Civil Registrar of Salcete, Margao, Goa.

who have stated on oath that the previous marriage of the proposed bride of the applicant is annulled and that the applicant and his proposed bride Ms. Swezel Vandy Fernandes are unmarried and there are no legal impediments to their marriage.

10. The previous marriage of the proposed bride of the applicant Ms. Swezel Vandy Fernandes is annulled and her marriage is already cancelled pursuant to Judgment and Decree dated 11.04.2025 passed by the Court of the Civil Judge Senior Division at Margao, Goa bearing Case No. MP/12/2025/I and the cancellation certificate of the Marriage Teor is also produced on record. Therefore from the overall discussion held herein above, the documentary proof and the affidavits that are sworn by the applicant, his fiancée and all the witnesses it appears that there are no any legal impediments for both of them to get married to each other. Therefore, thereby invoking my powers under Article 248 of Portuguese Civil Code, I pass the following:-

O R D E R

The application filed by the applicant stands allowed.

The applicant Mr. Aldrich Ryan Fernandes and his fiancée Ms. Swezel Vandy Fernandes are permitted to register their marriage before the Office of the Civil Registrar of Salcete, Margao, Goa thereby complying with all the necessary formalities required before the said Authority and this Order shall be treated as the Certificate issued under Article 248 of the Portuguese Civil Code.
