Accused Lakhiram Hembram is produced under arrest before this court and he is taken into custody.

Ld. Special P.P in charge and the Ld. Advocate for the accused are present.

One bail petition is filed on behalf of the accused Lakhiram Hembram on the ground stated therein along with vokalatnam.

The I.O of this case prays for police remand of accused Lakhiram Hembram for 05 days by filing forwarding letter duly forwarded by the Assistant Commissioner of Police, Kanksa, ADPC, District Paschim Bardhman on the grounds of collecting more evidence on the basis of statement given by him.

The I.O. submitted that in order to unearth the full facts of the case, **05 days** Police Remand is required and as such, he prays for granting **05 days** Police Custody of the accused Lakhiram Hembram.

Seen the C.D and the documents filed with the forwarding letter of the accused and it is transpired from the FIR that the case has been registered against the accused under section 64(2)(m)/351(2) of BNS & 4/6 POCSO Act.

The prayer of police remand of accused Lakhiram Hembram is allowed for 05 days in the interest of investigation. Accordingly, accused Lakhiram Hembram is remanded to police custody for 05 days.

On being asked accused submits that he has no injury. This court also does not find any fresh injury on his person on the basis of superficial observation.

I.O. is directed not to inflict any type of torture upon the accused during the period of police custody and also directed to abide by the guidelines of Hon'ble Apex Court passed in **D.K. Basu's Case** as well as guidelines of the Human Rights Commission of India in its letter and spirit. IO is further directed to make necessary arrangement for medical check up of the accused every 48 hours during PC period.

As the accused has been remanded to Police Custody for 05 days, as such, the bail application filed on his behalf has become infructuous.

Another prayer is made by the I.O for medical examination of the accused Lakhiram Hembram on the ground stated therein.

Perused the prayer of I.O.

Prayer is allowed.

The Superintendent, SD Hospital is requested to arrange medical examination of accused Lakhiram Hembram.

I.O is directed to produce the accused Lakhiram Hembram before doctor at SD Hospital, Durgpaur for medical examination.
