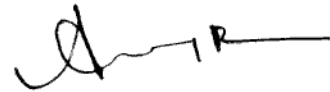

JUDGMENT

Accused appeared before Court. Particulars of offence are read over and explained to him to which he pleaded guilty. His plea is accepted as it appears to have been made voluntarily. Accused prayed for leniency. Ld. APP submits that maximum punishment may be imposed. Considering the submissions made by both sides, I pass the following order.

ORDER

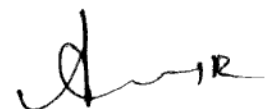
1. Accused viz. Jainul Abdul Majid Khan is hereby convicted vide Section 275 of BNSS, for the offences punishable U/sec. 223, 285 of The Bhartiya Nyay Sanhita, 2023.
2. Accused is sentenced to pay fine of Rs. 2,000/- i.d. accused to suffer S.I. for 10 days for the offence punishable u/sec 223 of BNS.
3. Accused is sentenced to pay fine of Rs. 3,000/- i.d. accused to suffer S.I. for 15 days for the offence punishable u/sec 285 of BNS.
4. His bail bonds, if any, stand cancelled. The amount of cash surety, if any, be refunded to the accused forthwith.
5. Copy of judgment be given to accused forthwith free of cost.
