Name of accused persons : hereby charge you 1. Subrata Dey 2. Rina Dey, 3. Kanika Dey, 4. Debabrata Dey and 5. Sougata Dey.
as follows :

Firstly -That all of you being the husband and in-laws of the deceased Munna Dey in furtherance of common intention subjected her to both physical and mental cruelty since after her marriage on illegal demand of dowry and you all have thereby committed an offence punishable u/s 498A/34 I.P.C within the cognizance of this court.

Secondly -That on 02.06.2017 at about 7-00 p.m, evening accused Surjakanta Dey, father of the accused Subrata Dey gave information of suicide of deceased Munna Dey to the uncle of Munna Dey, namely Swapan Kumar Roy and you being the accused persons i.e. husband and other in-laws in furtherance of common intention abetted its commission by subjecting her to both physical and mental cruelty immediately prior to her committing suicide and thereby committed the offence punishable u/s 306/34 of the IPC and within the cognizance of this court.

And I hereby direct that you all be tried by the said Court on the said charge.

Charges are read over and explained to all the accused persons to which each of the accused persons pleads not guilty by saying '*ami nirdosh*' individually and claimed to be tried.

Perused the FIR, Charge sheet, C.D. and other materials on record. Considered.

On perusal I find that there are sufficient materials for presuming that all the accused persons namely, 1. Subrata Dey 2. Rina Dey, 3. Kanika Dey, 4. Debabrata Dey and 5. Sougata Dey have committed offences u/s 498A/306/34 of I.P.C.

Accordingly, charges u/s 498A/306/34 of I.P.C. against all the accused persons namely have been established. The charges are framed in a separate sheet which is kept with the record.

The contents of charge is read over and explained to all the accused persons in Bengali to which all the accused persons plead not guilty by saying ‘Amra nirdosh’ and claim to be tried.

Accordingly a schedule be fixed for the evidence of the prosecution witnesses;

25.04.2023 for evidence of C.S.W no. 2
26.04.2023 for evidence of C.S.W no. 3

Ld. P.P in-charge is to serve summons upon the C.S.W.s accordingly.
