Order No. 02 dated 24-11-2025

Accused Totan Khan @ Goni Khan is produced from from JC. He is taken into custody.

A vokatnama is filed on behalf of accused Totan Khan @ Goni Khan.

A bail petition is filed on behalf of accused person namely Totan Khan @ Goni Khan.

This Court is lying vacant. S.P.Chattopadhyay, ASJ, FTC, 2nd Court, Burdwan is in charge.

Now the bail application, filed on behalf of the accused Totan Khan @ Goni Khan is taken up for hearing.

Heard submission on behalf of the accused person and it is submitted that this accused person is in custody since 05-07-2025, he is falsely implicated in this case, he has hearth and home, charge sheet is submitted u/s 69 of BNS against accused Totan Khan @ Goni Khan there is no necessity to keep the accused behind the bar for the purpose of investigation and he may be enlarged on bail upon any condition.

Ld. Special PP in charge referred the materials of the CD, raised objection and leaves the matter at the discretion of this Court.

Perused the materials of the record as well as the CD, returned CD.

On perusal of the case record it appears that charge sheet is submitted u/s 69 of BNS against accused Totan Khan @ Goni Khan on perusal of the case record and CD it appears that there was love affairs between the parties, investigation has already been completed, accused person is in custody since 05-07-2025, so, considering the facts and circumstances, the prayer for bail of the accused Totan Khan @ Goni Khan may be considered and allowed.

The accused person namely Totan Khan @ Goni Khan may be enlarged on bail upon furnishing bond of Rs. 5,000/- with two sureties each of Rs.2,500/- one of whom must be local in the form of FD/NSC, subject to the satisfaction of Ld. ACJM, Kalna id to remain in JC till 16-01-2026.

This bail is of interim in nature having validity till 16-01-2026.

If on bail to 16-01-2026 for appearance of the accused person namely Totan Khan @ Goni Khan id. Production from JC, and for appointment of Ld. PP in charge.

Let a copy of this order be forwarded to the Ld. ACJM, Kalna and to the Controller, Sub-Correctional Home, Kalna for information and necessary action.

To 16-01-2026 for appearance of the accused person namely Khokan Molla id. Production from JC, and for appointment of Ld. PP in charge.
