Order No. 12 Dtd. 13-08-2025

Record is put up today on the basis of application filed on behalf of the accused Rahul Majhi.

Another application is submitted on behalf of accused Rahul Majhi informing this court about the necessary order passed by Hon'ble High Court, Calcutta in connection with C.R.M(M) 745 of 2025 dated 07-08-2025, along with Certified copy of the said order supported by an affidavit about the authenticity of the said document.

Hon'ble High Court, Calcutta was pleased to pass the order in connection with C.R.M(M) 745 of 2025 dated 04-08-2025 and CRAN 1 of 2025 (Modification), as follows :-

“ Accordingly, the petitioner namely Rahul Majhi be released on bail upon furnishing a bond of Rs.10,000/- with two sureties of like amount each, one of whom must be local to the satisfaction of Learned Additional Sessions Judge, Kalna cum Judge, Special Court (POCSO Act), Kalna, Purba Bardhaman, subject to condition that the petitioner shall report to the Inspector-in-Charge of the concerned Police Station once in a fortnight. The petitioner shall not enter the jurisdiction of Monteswar Poice Station except for the purpose of attending court proceedings and reporting to the Inspector in Charge of the concerned Police Station. The petitioner shall furnish the address where he shall presently reside before the Learned Trial Court, the investigating officer and the Inspector-in-Charge of the Police Station under whose jurisdiction he shall be presently reside. The petitioner shall appear before the Learned Trial Court on each and every date fixed and shall not intimidate the witnesses and/or tamper with evidence in any manner whatsoever.

In the event the petitioner fail to comply with the conditions as enshrined hereinbefore, it is open to the trial Court to cancel the bail without further reference to this court”.

In view of submission the order of Hon'ble High Court, Calcutta, passed in connection with C.R.M(M) 745 of 2025 dated 04-08-2025 and CRAN 1 of 2025 (Modification) dated 07-07-2025 is modified only to the extent that the petitioner namely Rahul Majhi be released on bail upon furnishing a bond of Rs.10,000/- with two sureties of like amount each, to the satisfaction of Learned Additional Sessions Judge, Kalna cum Judge, Special Court (POCSO Act), Kalna, Purba Bardhaman, subject to condition that the petitioner shall report to the Inspector-in-Charge of the concerned Po0lice Station once in a fortnight. The petitioner shall not enter the jurisdiction of Monteswar Poice Station except for the purpose of attending court proceedings and reporting to the Inspector in Charge of the concerned Police Station. The petitioner shall furnish the address where he shall presently reside before the Learned Trial Court, the investigating officer and the Inspector-in-Charge of the Police Station under whose jurisdiction he shall be presently reside.

The petitioner shall appear before the Learned Trial Court on each and every date fixed and shall not intimidate the witnesses and/or tamper with evidence in any manner whatsoever.

The accused Rahul Majhi filed one bail bond of amount Rs.10,000/- submitted by surety namely Tapas Kumar Pal which bears LTI of the accused duly attested by Controller, Kalna Sub-Correctional Home; another bail bond of amount Rs.10,000/- submitted by surety namely Samarjit Sengupta which bears LTI of the accused duly attested by Controller, Kalna Sub-Correctional Home,

One Mithu Majhi has submitted a copy of letter dated 07-08-2025 addressed to the Inspector in Charge, Katwa Police Station, Purba Bardhaman informing that the accused Rahul Majhi will reside at Kamal, PO-Jamra, PS-Katwa, Dist-Purba Bardhaman.

One Mithu Majhi has submitted a copy of letter dated 07-08-2025 addressed to the Inspector in Charge, Monteswar Police Station, Dist-Purba Bardhaman, informing that the accused Rahul Majhi, will reside at Kamal, PO-Jamra, PS-Katwa, Dist-Purba Bardhaman.

As this establishment do not maintain register of sureties, Ld. ACJM, Kalna is directed to check the bonds as above and if found fit, the same to be noted and sent back before this court by 4 PM this day for further compliance of the order passed by Hon'ble High Court, Calcutta.

Let the bail bond of amount Rs.10,000/- submitted by surety namely Tapas Kumar Pal which bears LTI of the accused duly attested by Controller, Kalna Sub-Correctional Home and other bail bond of amount Rs.10,000/- submitted by surety namely Samarjit Sengupta which bears LTI of the accused duly attested by Controller, Kalna Sub-Correctional Home, Affidavit of Mithu Majhi and identified by Advocate Sneha Pandey, xerox copy of Aadhar Card of Mithu Majhi be sent to the Ld. ACJM, Kalna to check and fit them only and return immediately to this establishment.

Let a copy of this order be also sent to Ld. ACJM, Kalna along with the bonds.
