Present Misc. case is arising out of an application u/s 483 of BNSS in connection with Nadanghat P.S. Case No. 156 of 2026 dated 11-04-2026 and GR case No. 625 of 2026 with a prayer for granting bail to the petitioner.

Today is fixed for hearing of bail petition of petitioner Laltu Seikh.

Ld. Advocate for the petitioner at the time of hearing submitted that the petitioner is in custody since 15.04.26 and other co-accused persons are on bail. He further submits that prayer for bail of this accused was lastly rejected 21.5.26 and since then there is no development and therefore the accused persons may be enlarged on bail. He further submits that no prayer for bail of this petitioner is either pending before or rejected by the Hon'ble High Court.

Ld. PP in charge, while opposing the prayer submitted that victim was severely assaulted by the accused person and the CD shows that there were about 45 stitches on the head of the victim. He further submits that the weapon of offence was recovered from the accused person and therefore he should not be released on bail.

Considered the submissions of both sides.

Perused CD and materials on record.

It appears that there is allegation in the FIR that this petitioner along with other co-accuse persons assaulted Taher Ali Sk, Sajan Sk and Sekendar Sk. Injury report of all those persons are lying with CD and in respect of victim Sajan Sk it appears that he sustained serious injury on his head. It also appears that during the period of PC one iron rod and piece of bamboo were recovered at the behest of this accused person.

Considering the serious nature of offence I am not inclined to entertain the prayer for bail and the same stands **rejected**.

Return CD.
