Within the envelope the report of Medical Board in connection
with M.T.P of the minor VG of this case is forwarded along with observation
of the Board that M.T.P should be done at higher center considering the age
and high risk.

In view of the circumstances, this Court permits the prayer of the
IO to arrange M.T.P of the minor VG of this case in the backdrop of her
consent as well as the consent of her guardian.

Superintendent, Kalna SD & SS Hospital, Purba Bardhaman, is
requested to arrange M.T.P of the minor VG of this case and to preserve the
umbilical chord and blood and minimum portion of the foetus for the purpose
of investigation.

IO of this case is present, Ld. Advocate on behalf of accused
person and Ld. Spl PP in charge are also present.

Heard submission on behalf of all the persons about prayer of the
IO, for collection of blood sample of the accused for the purpose of matching
D.N.A, with the foetus.

Ld. Advocate on behalf of accused raises no objection.

Accordingly prayer of the IO is allowed.
