praying for bail on the ground stated therein.

Ld. Advocate for the accused person as well as the Ld. Spl. PP in charge
are present. Ld. Spl. PP in charge files memo of appearance. C.D. is produced by
the Ld. Spl. PP in charge.

Bail petition is also moved by the Ld. Advocate for the accused person
by submitting before this Court that this accused is in custody since 17.08.2023 and
he has been falsely implicated in this case. Moreover, it has been further submitted
by the Ld. Advocate that charge sheet has been submitted in this case. So he prays
for bail.

Ld. Spl. PP in charge opposes the bail petition.

On perusal of the materials on record, and other materials on C.D. I find
that investigation has already over as charge sheet has already been submitted. So
there is no necessity to detain the accused for the purpose of investigation. So
prayer for bail is allowed.

Accordingly, accused person, namely, **Hasem Ali Sk** may find bail of
Rs.5,000/- with two sureties of Rs.2,500/- each along with condition not to threaten
in any means and also not to disturb the V.G. during the pendency of the trial to the
satisfaction of the Ld. ACJM, Kalna i.d. to J/C till date.

C.D. be returned.

If on bail, to date (**06.10.2023**) for appearance of accused person and
supply of copy.
