Accused Sujan Soren @ Sujan Sk @ Sirajul Sk is produced from J/C.

Today is fixed for hearing bail petition which was filed on 03.06.2024.

Ld. Advocate for the accused person and the Ld. Spl PP in-charge are present.

Bail petition is moved by the Ld. Advocate for the accused person submitting that the accused person is behind the Bar since 30.04.2024 and there is no serious offence committed allegedly by the accused as per written complaint and the accused is innocent, so he may be enlarged on bail.

Ld. Spl PP in-charge raises objection in granting bail to the accused person and referred the materials available in the CD.

Perused the materials in the case record as well as the CD.

The accused is behind the Bar since 30.04.2024. As per CD there is nothing significant which requires custodial interrogation of the accused person.

In the circumstances, the bail prayer on behalf of accused Sujan Soren @ Sujan Sk @ Sirajul Sk is considered and allowed.

Accused person Sujan Soren @ Sujan Sk @ Sirajul Sk may be enlarged on bail on furnishing a bond of Rs.4,000/- with two registered sureties each of Rs.2,000/- with following conditions i.d. to remain in J/C till 18.06.2024, subject to satisfaction of Ld. ACJM Kalna.

The following conditions to be observed by the accused :-

i) This bail is of interim nature having validity till 18.06.2024.

ii) The accused is to meet the IO of this case once in a week until submission of charge sheet;

iii) The accused not to indulge in, inducing and threatening the V.G. or her family members in any manner during enjoyment of his liberty ;

If on bail, to **18.06.2024** for appearance i.d. production of accused from J/C and submission of report by the IO.
