FINAL ORDER

2023)

This Inventory Proceeding is initiated upon the death of above deceased persons who died 21.06.1948 and 29.12.1996 respectively without any Will or any other disposition of their last wishes, leaving behind the applicant and others as their legal heirs.

2. The Applicant was appointed as the Head of the Family vide Order dated 01.12.2022 passed on exhibit 1. Oath of HOF administered at exhibit 4. The Statement on Oath of the Head of the Family is filed at Exhibit 5.

3. Initial list of assets is filed at exhibit 13, Order passed to place documents. Memo placing documents on record is filed at exhibit 15 which is accepted. The application for waiver is filed at exhibit 16 which is granted.

4. The Final List of Assets is at exhibit 17. Auction is held on 20.06.2023. Minutes of Auction is drawn at exh 26. Application is filed for depositing owelty money at exh 27. Memo is filed at exh 28 placing the receipts of owelty money. Scheme of Partition is filed at exh 29. The Provisional Chart of Allotment is filed at exhibit 30 which is not objected and hence by second Order passed on exhibit 30, the same is accepted as the Final Chart of Allotment. The Head of the Family filed a memo at exhibit 31 colly, placing the stamp duty of Rs.3,100/- on record.

5. Thus the share of the Head of the Family and the Interested Parties is confirmed as per the Provisional Chart of Allotment at exhibit 30 which is accepted as the Final Chart of Allotment.
