This case coming on this day, the Court passed the following:-

ORDER

The case arose from final report filed by the Sub Inspector of Police, Chathannur Police Station in Crime No. 308/2025 alleging that the accused committed offences punishable u/ss. 126(2), 296(b), 74, 351(2), 75(3), 79 and 3(5) of BNS.

2. The prosecution case in brief is as follows:- At 7.00 pm on 11.02.2025 accused no. 2 to 4 showered abusive words at CW1 and called her 'Vanam'. At 7.30 pm at Varinjam Subramanyam Temple compound CW1 shared the information with accused no. 1 who is the father of accused no.3 following which he caught hold of her shoulder and hand. She resisted the same and got herself seated nearby. Then accused no. 1 further touched her shoulder and hip whereby he outraged her modesty. Accused no. 1 made sexually coloured remarks and uttered abuses in her ear. He also threatened to kill her father. Thereby the accused has committed the offences punishable u/ss. 126(2), 296(b), 74, 351(2), 75(3), 79 and 3(5) of BNS.

3. Accused no. 1 and 3 arrested and remanded to judicial custody on 14.02.2025. Accused no. 1 and 3 were enlarged on bail as per the order of Hon'ble High Court of Kerala vide Bail Appl. No. 3413 of 2025 dated 13.03.2025. Accused no. 2 and 4 appeared before court on 27.06.2025 and they were enlarged on bail. Copies of all relevant prosecution records were given to the accused and thereby mandate u/s. 230 of BNSS was complied with.

4. Heard the learned counsels for the accused and the learned Assistant Public Prosecutor. Perused records.

5. Since the offences alleged against the accused are exclusively triable by the Hon'ble Court of Sessions, this case is committed to the Hon'ble Court of Sessions, Kollam as provided u/s. 232(a) BNSS.

6. Submit the records of the case, documents, articles if any u/s.232(c) of Bharatiya Nagarik Suraksha Sanhita, 2023 and property if any shall be sent subject to Rule 77(2) of Criminal Rules of Practice, Kerala.

7. Notify the Public Prosecutor of the commitment of the case to the Court of Sessions u/s. 232(d) of Bharatiya Nagarik Suraksha Sanhita, 2023.

8. The office is directed to keep certified copies of all relevant records before sending to the Hon'ble Court of Sessions.
