Applicant/accused are seeking extension of time to furnish sureties.

2. Perused the applications. Ld. SPP has given say on the applications itself by objecting the prayers.

3. It is stated in the application at Exh.18 that pursuant to bail order dated 24.4.2018 passed by this court, the applicant no.1 had deposited provisional cash bail before this Court on 2.5.2018. Further as she was in judicial custody in another case registered at Pune, recently she has been granted bail by Hon'ble

Bombay High Court, wherein she has furnished the necessary surety. She therefore could not furnish the solvent surety before this Court within time. It is stated in the application at Exh.19 that the present applicant/accused no.2 has been granted bail by this Court on the condition of furnishing solvent surety.

4. The applicants could not furnish the solvent sureties before this Court within time and they are making attempts to find out the same. Hence further time is sought till next date.

5. On hearing both sides and in view of the averments made in the applications, I find that the applicants can be granted opportunity to furnish sureties till next date. Hence following order is passed.

ORDER

1. Applications are allowed.

2. Time is granted to applicants/accused no.1 & 2 to furnish sureties till next date.
