Firstly- That on 17.02.2017 at about 11:00 a.m. at Village Duli, PS Gangajal Ghati, Dist. Bankura all of you in furtherance of your common intention attempted to commit murder of Amrit Ghosh, the de-facto complainant of this case, by physically assaulting him on his head with an axe and thereby committed an offence punishable under Section **307/34** of the Indian Penal Code and within the cognizance of this Court.

Secondly- That on the said date, time and place all of you in furtherance of your common intention physically assaulted the wife and son of the de-facto complainant namely Brinda Ghosh and Prasanta Ghosh with lathi, axe and iron rod and thereby you committed an offence punishable under Section **324/34** of the Indian Penal Code and within the cognizance of this Court.
