CHARGES WITH THREE HEADS
(No. XXVIII (II), Schedule V, Act V, 1898)

I, Shri Teerthankar Bhattacharyya,
Additional Sessions Judge, Fast Track Court, Bankura

hereby charge you Accused 1) Sekh Azaharuddin and (2) Tapas Ghosh.
as follows :

Firstly – That you, on 13-07-2022 at about 11.45 hours in furtherance of common intention illegally carrying sand loaded with in a dumber bearing No. WB39B/4417 from Gangajalghati towards Dhaldanga and thereby all of you have committed an offence punishable u/s 379/34 I.P.C. and within the cognizance of this court.

Secondly- That you, on 13-07-2022 at about 11.45 hours in furtherance of common intention dishonestly extracted sands from Mejia river under District Bankura having reason to believe that such sands were stolen and thereby committed an offence punishable u/s 411,34 of I.P.C and within the cognizance of this Court of Sessions.

Thirdly- That you, on 13-07-2022 at about 11.45 hours in furtherance of common intention was habitually received and/or dealt with stolen illegal sands and thereby committed an offence punishable u/s 413,34 of I.P.C and within the cognizance of this Court of Sessions.

And I hereby direct that you be tried by the said Court on the said charge.

The charges are read over and explained to the accused persons in Bengali to which they plead not guilty and claim to be tried.
