PW/ DO Rajbala is present, however, discharged unexamined for today as she has not brought the requisite register with regard to DD entries.

Put up for PE on 20.03.2026. PW/ DO Rajbala is bound down for NDOH with directions to bring the requisite register with regard to DD entries. Summons be issued to witnesses ACP Mahesh Kumar and HC Sudesh mentioned at serial nos. 17 and 18 the list of witnesses for NDOH. IO as well as MHC(M) along with case property be also summoned for NDOH.

In view of submissions made, application of above mentioned applicant/ owner Vishal Choudhary stands dismissed as withdrawn.

The present applicant Ajay Singh stood surety for the accused Pushpender with respect to interim bail granted to accused Pushpender vide order dated 28.11.2025 and two original FDRs of account no. 602300DP00038303 and 397900PU00177525 for total amount of

Rs. 50,000/- (Rs. 30,000/- and Rs. 20,000/- respectively), of surety Ajay Singh were retained on record while accepting the bail bond. Thereafter, the accused Pushpender had surrendered himself before the jail authorities after expiry of interim bail. Since, the accused Pushpender has already surrendered, the bail bond furnished on his behalf at the time of releasing on interim bail stood discharged. **As such, the present application is allowed and two original FDRs 602300DP00038303 and 397900PU00177525 for total amount of Rs. 50,000/- (Rs. 30,000/- and Rs. 20,000/- respectively), of applicant / surety Ajay Singh be released to him after due acknowledgment.**

Application is accordingly disposed of.
