The application u/s 482 of B.N.S.S. filed on behalf of the petitioner/accused, namely, Swapan Murmu in connection with Chhatna P.S. Case No. 43/2026 dt. 24.04.2026 u/s. 85/115(2)/117(2)/109/351(3) of B.N.S. is taken up for hearing.

TCR is received. C.D. is also produced.

Heard the Ld. Lawyer for the petitioner/accused namely, Swapan Murmu.

Heard the Ld. Public Prosecutor.

Ld. Advocate for the petitioner/accused has submitted that no bail petition is pending before the Hon'ble High Court, Calcutta.

An affidavit has been filed on behalf of the petitioner/accused swearing that no application u/s 482 of the BNSS has been filed before the Hon'ble Court.

It is found upon perusal of the affidavit, duly furnished on behalf of the petitioner/accused, that no case is pending before the Hon'ble High Court in connection with the present case.

Ld. Advocate for the petitioner/accused has submitted that the petitioner/accused is innocent and has falsely been implicated in this case.

It is also submitted that victim/wife is residing separately since long.

It is also submitted that the act of the defacto complainant is nothing but provocation on her part.

Thus, Ld. Advocate has prayed for anticipatory bail on any terms and condition as this court may deem fit and proper.

Ld. Public Prosecutor raised objection and draws the attention of this court to the injury report.

Perused the written complaint, formal FIR, L.C.R and C.D.

Considered.

The injury report as perceived is not inspiring to detain the accused and curtail his liberty.

Justice could be substantiated if the accused/petitioner be released on bail on suitable terms and conditions.

Hence,

Ordered

that prayer for anticipatory bail is allowed on condition.

In the event of arrest, petitioner/accused shall be released on bail upon furnishing a bond of Rs. 4,000/- with two registered sureties of Rs. 2,000/- each subject to the satisfaction of Ld. CJM, Bankura, on condition that after release on bail, he shall strictly comply with the provision u/s 482(2) of B.N.S.S. and with a condition to surrender before Ld. CJM, Bankura within 15 days from the date of this order for regular bail which shall be considered by Ld. CJM, Bankura, u/s 480 of B.N.S.S. and on further condition :

1. that the petitioner/accused shall cooperate with the investigation and

3. shall not tamper the evidence or hamper the witnesses and

4. shall not threat the defacto complainant or witnesses in any manner whatsoever and

5. shall not create hindrance during investigation.

Return the C.D.
