Ld Advocate also files a petition and a net copy of order of the Hon'ble High Court, Calcutta passed in CRM(DB) 789 of 2025 as follows :

"...

5. Accordingly , we direct that the petitioner, namely **Kushamoy @ Gobra Goswami**, shall be released on bail upon furnishing a bond of Rs.10,000/- with two registered sureties of like amount each, to the satisfaction of the Learned Judge, under POCSO Act, Bankura subject to condition that he shall appear before the trial court on every date of hearing until further orders and shall not intimidate witnesses or tamper with evidence in any manner whatsoever and on further condition that the petitioner while on bail shall remain within the jurisdiction of the concerned police station except for purpose of attending court proceedings and shall meet the I.C/O.C. of the said police station once in a fortnight until further orders.

6. In the event of the petitioner fails to adhere to any of the conditions stipulated above without justifiable cause, the trial court shall be at liberty to cancel his bail in accordance with law without further reference to this court.

7. The application for bail is, accordingly, allowed."

The accused is to file the bail bonds as per direction of the Hon'ble High court, Calcutta, before this court.
