Ld. PP-in-charge is present by filing hazira.

The bail petition is heard. Considered.

After thorough perusal of the materials on record including the documents already referred to above it has come to my notice that the accused for the first time appears in this Court and prays for bail and he has already paid the pilferage amount.

The Ld. P.P in-charge, though raised objection, after going through the above mentioned documents left the matter to the Ld. Court.

Considering the submissions made by the Ld. P.P in-charge and the Ld. Advocate for the defence, I am inclined to enlarge the accused on bail.

The accused Labu Gorai may find bail bond of Rs. 5,00/-with one registered surety of the like amount subject to the satisfaction of Ld. CJM, Bankura i.d to J/C till 16.02.2023.

As charge-sheet has already been submitted in this case and copies are lying with the record, the copies are served today.

If bond is furnished to 04.07.2023 for appearance of the accused.

Let a copy of this order be transmitted to the Ld. CJM, Bankura for his information and necessary action.
