ORDER

The claim petition filed by the claimant is allowed in part, with costs, as under:

Claimant is entitled for compensation of **Rs.9,81,518/-** (Rupees Nine Lakhs Eighty One Thousand Five Hundred and Eighteen only) along with interest at the rate of 6% per annum, from the date of petition till it's deposit.

Respondent Nos.1 and 2 are jointly and severally liable to pay the said compensation amount. However, respondent No.2 being insurer, is directed to deposit the compensation amount within the time stipulated U/Sec.168(3) of M V Act.

Soon after deposit, claimant is permitted to withdrawn the entire compensation amount.

After deposit, entire amount shall be released.

All the interim applications pending, if any stand disposed of.
