Today is fixed for evidence of DW.

Sole accused Prasenjit Mondal is produced from J/C physically.

Ld. Advocate for the accused as well as Ld. Public Prosecutor are present.

One witness namely Dr. Santosh Hanamant (MINAJAGI) on behalf of the accused is present and he is examined as DW 4 by Ld. Defence Counsel and cross-examined by Ld. Public Prosecutor and discharged.

The original medical record of Prasenjit Mondal and the attested copy of medical record of Prasenjit Mondal at Central Institute of Psychiatry at Kanke, Ranchi are marked as **Exbt. D4/DW 4 collectively and Exbt. D4(1)/DW 4 collectively (with objection)**. The identity card of Prasenjit Mondal is marked as **Exbt. D5/D.W. 4 (with objection)**.

Ld. Defence Lawyer files a petition with the list of witnesses as DW i.e. Dr. Apurba Mahato, Superintendent of Bankura District Correctional Home, Buddhadeb Mondal, Himangshu Mondal and Prasanta Ghosh for their evidence. Let it be kept with the record.

Copy served which is seen by Ld. Public Prosecutor.

Heard both sides. Considered the petition.

It appears that the examination of the above mentioned witnesses are necessary for determination of the mental state of the accused at the time of commission of the crime and thus, allowed.

Fix **09-09-2026** for DW of Dr. Apurba Mahato,

Fix **10-09-2026** for DW of Superintendent of Bankura District Correctional Home.

Fix **14-09-2026-2026** for DW of Buddhadeb Mondal, Himangshu Mondal,

Fix **17-09-2026-2026** for DW of Prasanta Ghosh.

Accused be produced on such dates fixed physically.

Ld. Defence Lawyer is directed to issue the summons upon the witnesses well before time.

At this stage, Ld. Defence Counsel on behalf of witness i.e. DW 4 Dr. Santosh Hanamant (MINAJAGI) files a petition praying for returning back the original medical case record of Prasenjit Mondal which has been filed today before the court and exhibited in this case on the ground stated therein.

Ld. Public Prosecutor raised no objection regarding return back the original case record.

Heard both sides. Considered the petition and it is allowed.

Hence, the original medical record of Prasenjit Mondal which has been as **Exbt. D4/DW 4 collectively** in this case is returned back to the witness i.e. DW 4 Dr. Santosh Hanamant (MINAJAGI).
