

CHARGES WITH FIVE HEADS
(No. XXVIII (II), Schedule V, Act V, 1898)

I, Susangeet Kumar Das.

Additional Sessions Judge, Fast Track Court, Bankura.

hereby charge you Accused **1) Sibü Ghosh, (2) Smt. Chandana Ghosh and
(3) Smt. Sandhya Rana.**

as follows :-

Firstly – That all of you, on 02-01-2024 at about 07.00 a.m. in furtherance of common intention committed house trespass by entering into the house of defacto complainant Joydeb Ghosh situated at Khayerbani under P.S Gangajalghati in the District of Bankura and that you thereby committed an offence punishable **u/s 448/34** of the Indian Penal Code within the Cognizance of this Court of Sessions,

Secondly – That all of you, in furtherance of common intention, on the aforesid date, time and place, voluntarily caused hurt to Maya Ghosh and Mahadeb Ghosh parents of the defacto-complainant by lathi which is a dangerous weapon and that you thereby committed an offence punishable **u/s 324/34** of the Indian Penal Code within the Cognizance of this Court of Sessions,

Thirdly - That all of you, in furtherance of common intention, on the aforesid date, time and place, voluntarily caused grievous hurt to Maya Ghosh and Mahadeb Ghosh parents of the defacto-complainant by lathi which is a dangerous weapon and that you thereby committed an offence punishable **u/s 325/34** of the Indian Penal Code within the Cognizance of this Court of Sessions,

Fourthly – That all of you, in furtherance of common intention, on the aforesid date, time and place, assaulted Maya Ghosh and Mahadeb Ghosh with lathi on their head with such intention or knowledge and under such circumstances that if by that act you had caused the death of Maya Ghosh and Mahadeb Ghosh, you would have been guilty of murder and that you thereby committed an offence punishable **u/s 307/34** of the Indian Penal Code within the Cognizance of this Court of Sessions.

Fifthly– That all of you, in furtherance of common intention, on the aforesaid date, time and place, committed criminal intimidation by threatening Maya Ghosh and Mahadeb Ghosh with injury to their persons or reputation or property with intent to cause alarm to them and that you thereby committed an offence punishable **u/s 506/34** of the Indian Penal Code within the Cognizance of this Court of Sessions,

And I hereby direct that you be tried by the said Court on the said charge.

The charges are read over and explained to the accused persons in Bengali to which they pleaded not guilty and claimed to be tried.
