Out of two accuseds Madhusudan Bhuin on court bail is present before this court by filing hazira and other accused -Tufan Bauri is produced from J/C.

Today, is fixed for hearing of bail petition filed on behalf of Tufan Bauri on 11.01.2022.

The bail petition is taken up for hearing.

Ld. Advocate for the accused and Ld. P.P-in-charge are present.

C.D. is produced.

Ld. Advocate for the accused person moves the petition for bail and submits for release of the accused person on the ground that the co-accused-Madhusudan Bhuin standing on the same footing has been granted bail by the Hon'ble High Court, Calcutta.

Ld. P.P-in-charge has raised objection in granting bail of the accused person.

Perused the server copy of the order passed by the Hon'ble High Court, Calcutta on 24.12.2021 in connection with CRM 7831 of 2021 where the Hon'ble High Court has been pleased to allow the bail prayer of accused-Madhusudan Bhuin on furnishing bond of Rs.10,000/- with two sureties of like amount each, one of whom must be a local, to the satisfaction of the learned Additional District and Sessions Judge, 1st Court, Bankura & Special Court under the NDPS Act, Bankura with a further condition that the petitioner shall not leave the jurisdiction of Patrasayer Police Station until further orders save and except for attending the learned Court below (the present court) on all the dates as specified for hearing. The petitioner shall not intimidate the witnesses or tamper with evidence in any manner whatsoever.

It is made clear that in the event the petitioner fails to comply with the aforesaid directions without any justifiable cause, the learned trial court would be at liberty to cancel his bail without any further reference to this Court.

Perused the materials on record and C.D wherefrom it is found that an intermediate quantity of contraband substance, being 1 Kg. 100 grms. of ganja was recovered from the possession of the accused. He has been languishing

behind the bar since long. Co-accused-Madhusudan Bhuin standing on the same footing has been granted bail by the Hon'ble High Court, Calcutta. Due to Covid situation there is no possibility of immediate trial.

Having considered the entire aspect the prayer for bail of the accused-Tufan Bauri is allowed.

The accused-Tufan Bauri may find bail of Rs.10,000/- with two sureties of Rs.5000/- each of which one must be a local subject to the satisfaction to the Ld. C.J.M, Bankura on condition that the accused-Tufan Bauri shall attend the court on the dates specified for hearing and shall not tamper with the evidence and/or intimidate the witnesses.

If bail bond furnished, Ld. C.J.M, Bankura is requested to issue the release order.

Send a copy of this order to the Ld. C.J.M, Bankura for information and necessary action.
