ORDER

The matter is placed before the lok adalat . Police present. Summons served. Accused is present. Copies furnished to the accused. Offence alleged against the accused is punishable U.Sec.338 of IPC. Accused is examined U.Sec. 251 Cr.P.C. The substance of accusation is read over and explained to him in Telugu. Having understood the same, accused is pleaded guilty voluntarily. Satisfied with the plea of guilt tendered by accused, as it is a voluntary one. Accordingly, the accused is found guilty under section 252 Cr.P.C. The accused is explained as to the quantum of sentence prescribed under the law. Plea of accused is considered and court is inclined to find guilty U.Sec.252 Cr.P.C for the offence U.Sec.338 of IPC against Accused. The accused submitted that this is only the case involved by him and he will be careful hereinafter. Hence, prayed the court to take lenient view considering the same. In the result, the accused is found guilty for the offence U.Sec.338 of IPC. As such, accused is convicted under Section 252 Cr.P.C. Accused is sentenced to pay a fine of Rs.500.00 (Rupees Five Hundred only) for the offence under Section 338 of IPC, in default of payment of fine, the accused shall undergo S.I for a period of one month. No property. Total fine amount is Rs.500.00. Office is directed to issue receipt for payment of fine, if paid, so also to remit the fine amount to the State forthwith.
