

CHARGES WITH TWO HEADS
(No. XXVIII (II), Schedule V, Act V, 1898)

I, Shri Teerthankar Bhattacharyya,,
Additional Sessions Judge, Fast Track Court, Bankura

hereby charge you Accused 1) Mithilesh Kumar, (2) Suresh Thakur, (3) Raju Bhuia, (4) Pravat ranjan Sinha, (5) Akash Sinha, (6) Nikhil Singh, (7) Ranjit Kewat, (8) Amit Kumar, (9) Ajit Kumar, (10) Vicky Kumar, (11) Pintu Singh @ Tiwariji .

as follows :-

Firstly – That you, on 15-03-2020 at or about 07.30 A.M. at village Hatmahatap Lane, P.S. & District - Bankura, entered into the house of Soumen Dutta and committed dacoity in respect of cash, gold ornaments etc. which were kept in that house and that you thereby committed an offence punishable u/s 395 of the Indian Penal Code within the Cognizance of this court of Sessions,

Secondly –That you, on 15-03-2020 at or about 07.30 A.M. at village Hatmahatap Lane, P.S. & District – Bankura, entered into the house of Soumen Dutta and committed dacoity and that at the time of committing the said dacoity you injected some substance upon the wife of Soumen Dutta, to wit, and made her senseless and that you thereby committed an offence punishable u/s 397 of the Indian Penal Code within the Cognizance of this court of Sessions,

And I hereby direct that you be tried by the said Court on the said charge.

The charges are read over and explained to all the accused persons in Bengali to which they plead not guilty and claim to be tried.
