The accused persons namely, Arun @ Naru Bauri, Jeeban @ Bijay Bauri and Ajit Bauri @ Jagu Bauri are produced from j/c.

Ld Spl P.P. in charge as well as Ld Defence counsels are present.

The record is taken up for consideration of charge.

Heard both the sides. Perused the materials on record together with the statement of the VG u/s 183 BNSS. I am of the view that there is sufficient materials for presuming that the accused Arun @ Naru Bauri has committed the offence punishable **u/s 10 / 12 of the Protection of Children from Sexual Offences Act, 2012**. Further it appears from the materials on record that there is sufficient material for presuming that the accused persons namely, Arun @ Naru Bauri, Jeeban @ Bijay Bauri and Ajit Bauri @ Jagu Bauri have committed the offence punishable **u/s 115(2)/76/3(5) BNS**.

Accordingly, the charge is framed against the above named accused persons. The substance of accusation is read over and explained to them to which they pleaded not guilty saying 'AMI NIRDOSH' individually and claimed to be tried. The formal charge is duly filled in and kept with the record.

The bail petition filed on behalf of the accused persons namely, Arun @ Naru Bauri, Jeeban @ Bijay Bauri and Ajit Bauri @ Jagu Bauri is taken up for hearing.

Ld advocate for the accused Arun Bauri submitted that the accused is in custody for about 85 days and investigation has been completed, so further detention of the accused is not necessary and prays for bail.

Ld advocate for the accused persons namely, Jeeban @ Bijay Bauri and Ajit Bauri @ Jagu Bauri submitted that there is no allegation of sexual assault against these accused persons and they are in custody since long and prays for bail.

Ld Spl P.P. in charge raised objection against the bail prayer of the accused persons.

Heard both sides. Perused the materials on record and I find that the allegation of sexual assault and sexual harassment upon the VG is against the accused Arun Bauri and not against other accused persons.

Considering the materials on record, the prayer for bail of the accused persons namely, Jeeban @ Bijay Bauri and Ajit Bauri @ Jagu Bauri is allowed. The prayer for bail of the accused Arun Bauri is hereby rejected and remanded to j/c till 17.02.25.

The accused persons namely, **Jeeban @ Bijay Bauri and Ajit Bauri @ Jagu Bauri** be released on interim bail of Rs.1,000/- each with one regd. surety subject to the satisfaction of the Id CJM, Bankura, on condition that they will appear on each and every date of hearing and shall not threat witnesses and tamper with the evidence in any manner whatsoever. On violation of any condition, the bail of the accused persons shall automatically be cancelled i.d. to j/c till 17.02.25.

Let a copy of this order be sent to the Ld CJM, Bankura.

To 17.02.25 for evidence, production and appearance of the accused persons.

Issue summons accordingly.
