J U D G M E N T

The accused is present before me today. He has pleaded guilty and has filed pursis to that effect vide Exh. 2. I have verified her and found pleading guilty voluntarily hence, accepted the plea and convicted for the offence charged.

Heard the accused on the point of sentence. She prayed leniency on the ground that, this is the first offence, she will never repeat the same in future. Her family member are depends on Her. Considering the facts and circumstances and the nature of offence I proceed to pass the following order in the interest of justice.

- O R D E R -

1. Accused is hereby convicted for the offense punishable under section 145B of the Railways Act as per section 275 of B.N.S.S. and thereby sentenced to suffer simple imprisonment till rising of the Court and to pay fine of Rs.1000/- (Rs. One Thousand only), in default of payment of fine, to suffer simple imprisonment for 03 days.
2. A copy of the judgment be given forthwith, to the accused free of cost.
