Order No. 24 dtd. 06.01.2024

Today is fixed for consideration of charge and hearing regarding the prayer of cancellation of bail of the accused Raj Kr. Purohit. The accused is present before the court along with his Ld. Advocate. One report has been received from the SI, Bidyut Kr. Dhua of Kotulpur PS to the effect that above named accused is residing in his village Deshra and not in any village under the PS Goghat in the district of Hooghly.

In this case, the accused was enlarged on bail by this court on 30.06.2023 subject to the condition that he shall stay outside the jurisdiction of Kotulpur PS and shall submit his new address to the investigating officer and this court. But on completion of the investigation, the IO submitted a prayer for cancellation of his bail on the ground that inspite of the above condition the accused is residing in his village within the jurisdiction of Kotulpur PS which the accused has denied by filing a petition and stated he is residing in his maternal uncle's house at village Fului under Goghat PS. Accordingly, a report has been called from OC, Kotulpur regarding the veracity of the submission of the accused. In reply to the same today's report has been submitted. The IO has also stated the Mobile Number of the accused is necessary to collect the Tower Location of the Mobile in order to ascertain the exact location during the aforesaid period.

Today the accused has filed an affidavit stating that he is residing for the present at village Fului under Goghat PS in the district of Hooghly and stated that since 08.12.23 he using the SIM No. 7029334717. It is also stated that his earlier SIM No. 9800995051 and SIM No. 6294818529 are not working.

In such circumstances let a copy of the affidavit of the accused along with copy of this order be sent to OC, Kotulpur PS for verification and finding out the Tower location of all three SIMs since 30.06.23. The OC is directed to submit the report on 10.01.2024 positively. At the same time, OC Goghat PS, District Hooghly is directed to submit a report whether accused Raj Kr. Purohit is staying at village Fului under Goghat PS in the district of Hooghly in the house of Subrata Chakraborty son of Lt. Sunil Chakraborty since 30.06.2023.

let a copy of this order be sent to OC, Goghat with a direction to submit the report by 10.01.2024 positively. The prayer for cancellation of bail will be considered on 10.01.2024.

Ld. Spl. PP has prayed for time regarding charge hearing. The prayer is considered and allowed. The charge against the accused shall be considered on 10.01.2024.

Fix – 10.01.2024 for consideration charge, hearing of bail cancellation prayer and report from both the PS.
