You were also found possessing gambling material and cash amount in contravention of the provisions of Maharashtra Prevention of Gambling Act 1887 and that you thereby committed an offence punishable under Section 12 (a) of the said act and within my cognizance.

J U D G M E N T

(Passed on this 09th September, 2023)

Since the accused persons have voluntarily pleaded guilty to the offence punishable under section 12 (a) of the Maharashtra Prevention of Gambling Act. The accused persons have admitted guilt in written vide Exh.2 and thereby expressed their willingness to plead guilty.

Heard, the accused persons on the point of sentence. They are repenting for the act, which they did. The accused persons voluntarily pleaded guilty at the beginning of the trial. No purpose would be served by sentencing them into the jail. Having regard to the circumstances of the case and nature of the offence, I pass the following order :

O R D E R

1. Accused **Nos.1 to 4** are **convicted** u/s. 252 of the Code of Criminal Procedure, 1973 of the offence punishable under section 12 (a) of Prohibition of Bombay Gambling Act and sentenced to suffer simple imprisonment till the rising of court and to pay fine of Rs.200/- each and I.D. of payment of fine shall undergo S.I. of two (2) days.
2. After appeal period is over :-
 - a) Cash Rs.4810/- be credited to State.
 - b) Gambling material, being worthless be destroyed.
