

CHARGE WITH FOUR HEADS
(No. XXVIII (II), Schedule V, Act V, 1898)

I, Shri Susangeet Kumar Das,
Additional Sessions Judge, Fast Track Court, Bankura,
J.O. Code – WB00973

hereby charge you, (1)

as follows :- **Sanjoy Patra,**

Firstly – that you, on 20-04-2025 at about 21.30 hours in front of his shop at village Nikunjuapur under P.S. Onda, District Bankura wrongfully restrained Asit Kumar Mukhapadhyay, the defacto-complainant when he was returning to his house after attending from marriage ceremony and that you thereby committed an offence punishable **u/s 126(2) of BNS** within the Cognizance of this Court of Sessions,

Secondly – that you, on the aforesaid date, time and place, voluntarily caused hurt to Asit Kumar Mukhapadhyay, the defacto-complainant by iron rod and that you thereby committed an offence punishable **u/s 115(2) of BNS** within the Cognizance of this Court of Sessions,

Thirdly – that you, on the aforesaid date, time and place, voluntarily caused grievous hurt to Asit Kumar Mukhapadhyay, the defacto-complainant by assaulting him on his head, above the left eye with the help of iron rod and that you thereby committed an offence punishable **u/s 117(2) of BNS** within the Cognizance of this Court of Sessions,

Thirdly – that you, on the aforesaid date, time and place, assaulted to Asit Kumar Mukhapadhyay, the defacto-complainant on his head, above the left eye with iron rod with such intent or knowledge or under circumstances that if by that act you had caused the death of said Asit Kumar Mukhapadhyay, you would have been guilty of murder and that you thereby committed an offence punishable **u/s 109(1) of BNS** within the Cognizance of this Court of Sessions,

And I hereby direct that you be tried by the said Court on the said charge.

The charges are read over and explained to the accused person in Bengali to which he pleaded not guilty and claimed to be tried.
